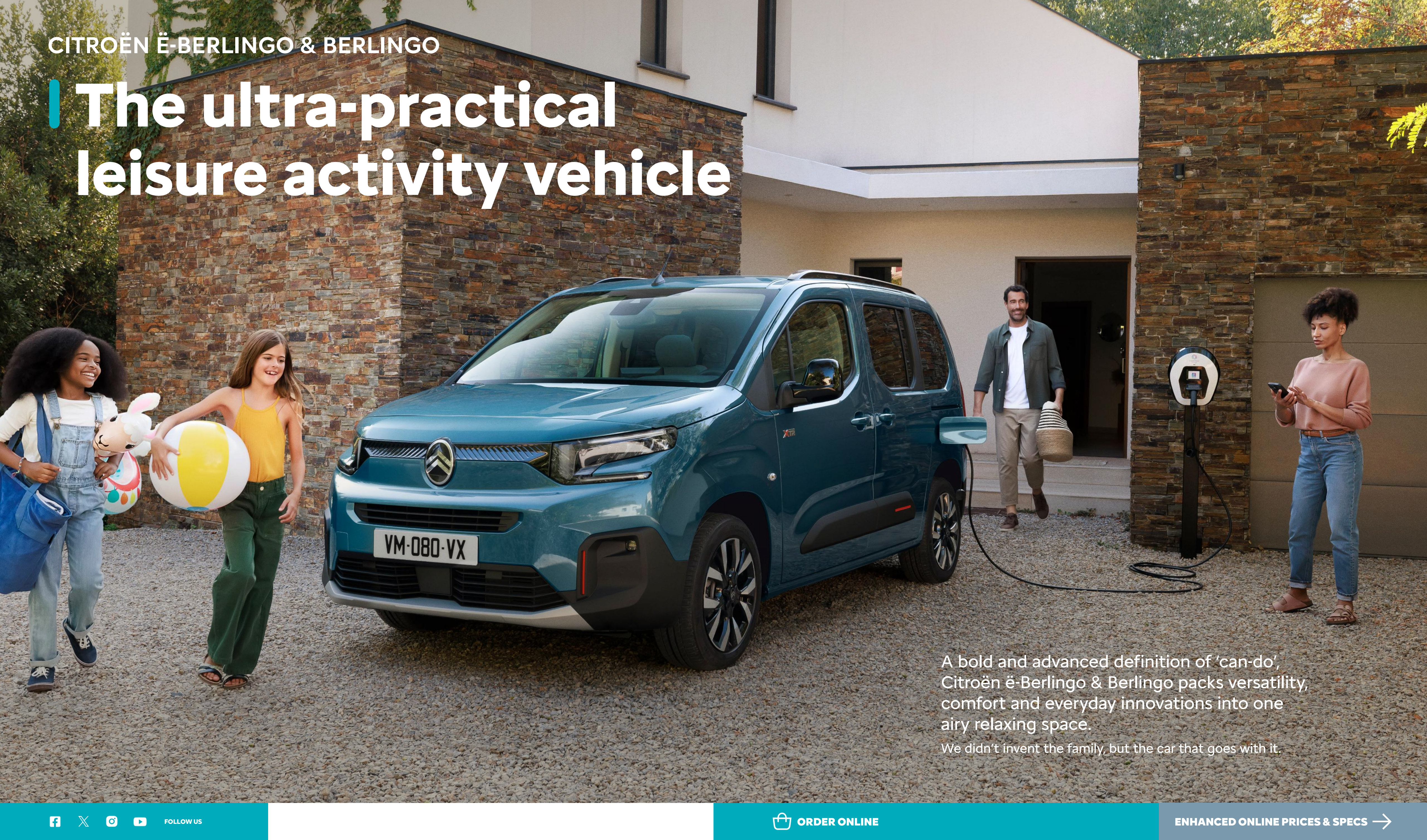

ë-Berlingo is a 100% Electric vehicle, with zero tailpipe CO2 emissions, powered by a rechargeable Lithium-Ion battery. Its 100 kW electric motor assures great performance (equivalent to 136 hp) with unprecedented refinement. The 52 kWh battery fitted as standard gives a range of between 206-212 miles (WLTP combined cycle - range dependent on use and driving style). It's easy to charge, with a practical charging cable and a handy deferred charging option. ë-Berlingo makes 100% electric driving accessible to more people than ever.

Can it really replace my petrol/diesel car?

Comfort: A virtually silent powertrain and the smooth delivery of electric propulsion complement the already benchmark levels of comfort offered by the Berlingo range.

Range: Between 206-212 miles which offers plenty of range for day-to-day driving and inter-city trips. Built-in capability for rapid charging opens up long-distance road trips too.

Driving experience: With 270 Nm of torque instantly available, ë-Berlingo is as at home on the open road as in the suburbs. No gear changes means perfectly smooth power delivery.

What about charging?

- The **included Type 2 charging cable** gives you accelerated charging at a home charging point or in public, compatible with the widest range of charging points. Because you charge your car when you aren't using it, you save time when you get on the road.
- ë-Berlingo also features a **rapid charging port** with the widely accepted CCS connector. You don't need to buy a cable for this because rapid chargers have the cable built in. On a 100 kW charging station you can get up to 80% charge from empty in just 30 minutes. So in the time it takes you to take a coffee break, you've effortlessly extended your car's range.
- You can buy a domestic charging cable as an accessory from your dealer for occasional charging from a 3-pin socket. Due to the limited speed of this charging method it is not recommended for regular use.

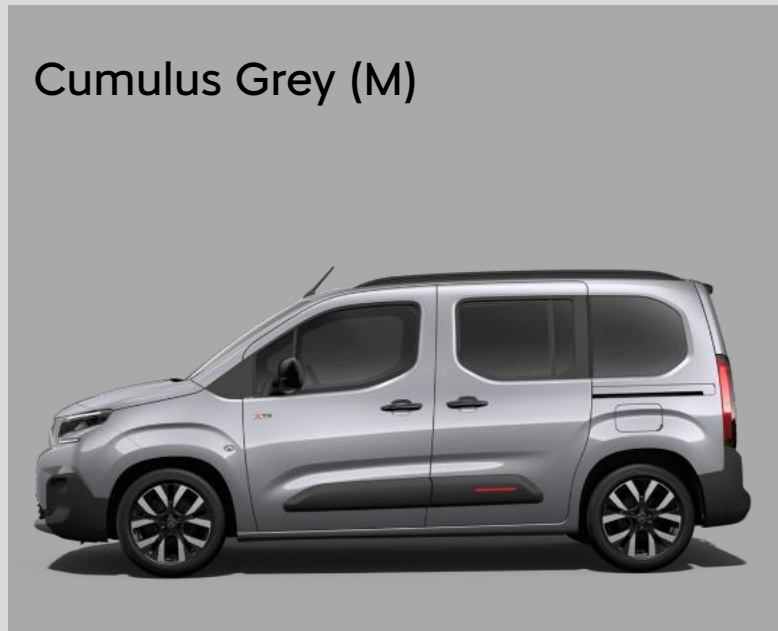
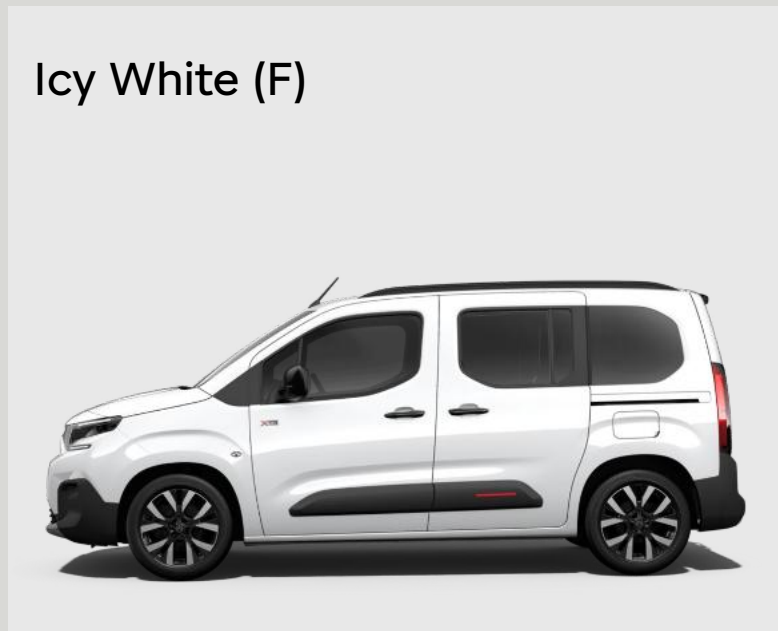

The Company Car Benefit-In-Kind Taxation charge is based upon the type of fuel used, and the level of CO₂ emissions, measured in grams per kilometre (g/km). The table below shows the percentage of the car's list price to be taxed (P11d value†).

For example a Citroen Berlingo Collection M Petrol 110hp manual has a CO₂ emissions figure of 143 g/km and a P11D value of £24,690 (as of April 2026).

The BIK calculation would therefore be 34% x £24,690 = £8,394.60

Graduated Vehicle Excise Duty (Road Fund Licence)

The Graduated V.E.D. bands classify all new cars into one of thirteen Vehicle Excise Duty bands, depending on their type of fuel and carbon dioxide (CO₂) emissions level, measured in grams per kilometre (g/km). There are two V.E.D. rates, a rate for the first year and a rate for subsequent years.
